Steps to be completed for membership:

- (1) The President will present the application to the Membership Committee.
- (2) The Membership Committee will review the application. The applicants Probationary Period begins at this time. The Probationary Period is a time for the applicant to get to know club members and to learn how the club operates.
- (3) The Probationary Period is maintained in a 180 day period however at any time while in the reviewing process the Membership Committee can request adjustment to the length of time in Probationary Period.
- (4) The Membership Committee will submit their recommendation to the President.
- (5) The President will present the decision of the committee to the entire body of the club at the next available meeting. The applicant cannot be present at the meeting during the presentation of the decision or during voting.
- (6) Members cast the final vote on acceptance or denial of the applicant.
- (7) After obtaining full membership status the applicant is expected to pay the required dues.
- (8) Members joining at any time during the 4th quarter of the year will have their 1st year's membership period extended until the end of the 4th quarter after their first full year of membership.
